TO WHOM IT MAY CONCERN

This is to state that I, **Mr./Ms.**, a BTech/ BDes student of the **Department of** of the Indian Institute of Technology Guwahati, bearing **Roll No.**, have secured less than the required CPI of 4.0 over the recent **2(Two)** consecutive registered semesters up to July- November 2020 semester. I am fully aware of the fact that, as per Clause 13.1(a) of the B.Tech Ordinances and Regulations, I am not eligible to continue in the BTech programme of the Institute.

However, notwithstanding the above, against my appeal, the Chairman of the Senate of the Indian Institute of Technology Guwahati, has very kindly provided me **one last and final chance** to show improvement in my academic performance by registering in to the January-May 2021 semester only, on the following conditions:

- (a) that I shall have to attend my classes regularly;
- (b) that I shall have to pass in all the courses permitted to register in January-May 2021; and
- (c) That I shall **meet/contact** my faculty advisor/ special mentor/ project supervisor at least twice in a week and discuss academic difficulties with him/ her for getting help. I fully understand that meeting/contacting him/ her twice in a week is mandatory; and
- (d) that if I fail to comply to the above conditions, I shall be terminated once and for all from the **BTech** programme of Indian Institute of Technology Guwahati, and I shall **NOT** appeal against such termination at any point of time in future.

I, with my full knowledge do hereby submit and assure that if I fail to comply to the above conditions, I shall be terminated from the **BTech** program of Indian Institute of Technology Guwahati; and that I shall not appeal against such termination at any point of time in future.
