সূচনা / NOTICE

The Institute is offering fee waivers for undergraduate students (**BTech/BDes/BS**) for which the students are required to submit/upload income certificate and affidavit for fee waiver. The details of the requirements for documents submission are as follows:

- Most Economically Backward (MEB) Students:** Most Economically Backward (MEB) Students are those GEN/GEN-EWS/OBC-NCL students whose annual family income from all sources is **below ₹1 lakh (Rs. 0 to Rs. 99999)**. The Tuition Fee is fully waived for MEB students.
- Other Economically Backward (OEB) Students:** Other Economically Backward (OEB) Students are those GEN/GEN-EWS/OBC-NCL students whose annual family income from all sources is between **₹ 1 lakh and ₹ 5 lakhs**. For OEB students two-third of the Tuition fee is waived.
- SC / ST / PWD Students:** For students belonging to SC / ST / PWD categories Tuition fee is fully waived. **SC / ST / PWD students need not submit / upload income certificate or affidavit for claiming fee waiver. Fee waiver is automatically applied as per their admission data.**
- Important Instructions for MEB/OEB Students for document upload:
 - Document Submission Requirements:**
 - Family Income Certificate:** Must be issued for the financial year **April 1, 2025 - March 31, 2026** by a competent authority (District Magistrate/Revenue Officer/Tehsildar), as per the proforma given in **Annexure-I** and **Annexure-II**. **The document must be issued after 1st April, 2026.**
 - Income Affidavit:** Must be submitted on **non-judicial stamp paper of ₹100**, for the financial year **April 1, 2025 - March 31, 2026** as per the proforma given in **Annexure-II**. **The document must be issued after 1st April, 2026.**
 - If the Income Certificate has multi-year validity (e.g., 3-5 years), the Income Affidavit must strictly be for the last financial year, i.e., 1 April 2025 - 31 March 2026, and must be prepared on or after 1 April 2026.**
 - Both the documents are mandatory.** Uploading only one (Income Certificate or Affidavit) will **not be considered valid submission.**
 - The **Income Affidavit must be on non-judicial of ₹100 stamp paper only**. Affidavits on lower denominations (₹10, ₹20, etc.) will **not be accepted.**
 - Document Format:**
 - Documents must be submitted in **PDF format** and should be **clear and legible**.
 - Scanned documents must not be hazy or unclear (e.g., those prepared using a smartphone).
 - Your **Institute Roll Number** must be visible on both documents.
 - Submission Process:**
 - Log into <https://academic.iitg.ac.in/sso/> with your **IITG ERP credentials** and click on the **"Document Upload"** link in the sidebar.
 - Upload the scanned PDF files of the **Family Income Certificate** and **Income Affidavit**.
 - Click the **"Upload"** button to complete the submission.
 - Deadline for Submission:**
 - The **deadline** for uploading the required documents is **5:00 PM on June 25, 2026**.
 - Documents submitted after this deadline will **not be considered**.
 - Important Notes:**
 - The fee waiver is subject to the **scrutiny** of the submitted documents by the Institute's competent authority.
 - Submission of false information will result in **penal action**, including recovery of the fee concession with interest and possible **legal action**.

Please ensure timely and accurate submission of the required documents to avail the fee waiver.
